This puppy is sold as a **Show/Breeding pet** for the price of _____ and under the following terms:

1. Seller agrees to provide health records, pedigree and copy of registration of both sire and dam. The registration of the dog will include as part of the name OCMINIaussies (ie – Spot of OCMINIaussies).
2. Seller guarantees the above dog to be in good physical and mental condition and free from disease at the time of sale. Buyer agrees to have the puppy examined by his/her own Veterinarian within 3 working days following possession by buyer. If any sign of illness is found (other than worms, diarrhea from change of diet, change in environment or travel stress, etc.), the buyer must contact the seller immediately. The buyer may elect to keep the puppy and assume the costs for it's care or may return the puppy for a full refund (seller to have copy of Vet statement regarding puppy's health). Any treatment started without the seller's approval will be at the buyers expense. Seller's intent is that the buyer be 100% satisfied with the purchase.
3. Buyer certifies that the puppy will live with the buyer, be confined by a fenced yard or other agreed arrangement and will have adequate exercise, nutritious food and necessary health care including all vaccinations.
4. If prior to this agreement, the puppy was determined to be breed quality and puppy was purchased as a breeding prospect, the buyer agrees as follows:
 - a) To have the hips and eyes certified and examined and OFA cleared at or after 24 months of age by a qualified Veterinarian prior to breeding.
 - b) To make sure that the potential mate for the dog also has eyes certified and OFA hip certification prior to breeding the dog.
 - c) If eyes or hips do not clear, buyer agrees not to breed the dog under any circumstances and contact the seller immediately. Failure to comply with this provision may result in forfeiture of the dog and return of the dog to the breeder.

- d) Buyer agrees not to breed the dog before 24 months and agrees to sign and follow NAMASCUSA breeder's code of ethics.
 - e) The dog will be under co-ownership with Kevin and Julie Webb until the above criteria is met at which time ownership will be signed over to buyer. If there are any puppies back, litter back or stud rights agreements involved in the purchase, these must be completed prior to releasing sole ownership to the buyer.
5. The buyer certifies that he/she is not acting as an agent in this purchase and in NO CIRCUMSTANCES will this dog ever be sold, leased or given to any pet shop, research lab, shelter, pound or similar facility.
6. If at any time in the dog's life, the buyer is unable to keep the dog, seller requests the buyer to contact the seller and requests the first right of refusal. If seller chooses not to exercise the right of first refusal, seller will assist buyer in finding the dog a new home. There will be no charge for board and care until the dog is re-homed, but it is the buyer's responsibility to get the dog to the seller. If buyer places the dog in a new home, buyer agrees to furnish seller with the name, address and contact information of the new owner. None of our dogs should ever end up in a pound or rescue.
7. **The buyer will Spay/Neuter the puppy at 6 months of age.** This dog was not suitable for breed/show and will require proof of spay or neuter before **Registration** papers will be sent to the buyer.

This contract is made and signed by both the seller and buyer for the well being of the said puppy. If the buyer breaches any part of this contract or special addendums attached to the contract, the seller can and will repossess the puppy.
